From 2018 to September 2021, he was director of human resources at the Ministry of Defence and was responsible for the resolution of the military pay crisis with the Louvois software. Philippe Hello has commanded four warships, he is Commander of the Legion d' honneur and Commander of the Ordre National du Mérite, holder of the Cross of Military Valour with citation, Officer of Maritime Merit, holder of the Commemorative and Overseas Medals with clasps "Hormuz", "Middle East", "Ex-Yugoslavia" and "Afghanistan", Commander with Swords "Pro Merito Militense" of the Sovereign Order of Malta.

Philippe Hello, stated: "I am very happy to be able to contribute to this magnificent ambition of building European digital sovereignty by bringing my experience of strategic security issues but also, and perhaps above all, of HR issues and organisation's transformation. Like any bold achievement, it is above all a human adventure which requires a precise course to be set but which will require a motivated and trained crew to stay the course over time".
